

在荆棘叢中大步走

困難是一把兩刃劍,可以阻礙我們的計劃,但同樣可以拉近支持者與我們的距離,也提醒我們在事奉的路上,依靠的不是我們自己,而是上帝的恩典,以及有同一心志和感動的教會及弟兄姊妹。機構的事工不是永恆的,對於上帝的旨意,我們要不斷心意更新和變化,以及敏銳於時代的變遷,才能繼續服事當前的社會、教會和弟兄姊妹。

對於明光社來說,當前的困難是財政再次出現壓力,自去年11月發出呼籲之後,深深感受到一些支持者對我們的關心,短時間內已令我們回復穩定。轉眼又過了接近一年,我們又迎來了新的挑戰,就是相繼失去了穩定的籌款機會,包括我們連續兩年的賣旗抽籤皆落空,今年更是在147個申請機構中,被抽中排第146揀位,而賣旗的名額只得74個,篤定在2027年3月底前沒有賣旗的機會,過往的賣旗活動我們可以籌得由60萬至過百萬元不等,是每年收入的重要來源之一。此外,今年我們第一次獲分配35個渣打馬拉松的慈善跑名額,籌得超過30萬元,但明年由於申請的機構超出過往很多,我們最終落選了,明年少了兩個重要的籌款活動,我們將失去超過100萬預計的奉獻收入。此外,今年年初我們的收支尚算平穩,但在4月之後,奉獻如往常一樣下降,至今累積赤字已約80萬元,儲備不足以應付兩個月的開支。

為了令我們關心的事工可以繼續發展,我們將會在2月底舉行明光大步走籌款活動,請大家支持我們的董事同工和友好挑戰港島徑,包括主席雷競業牧師和總幹事蔡志森會聯同想挑戰自己的友好,計劃在15個小時內完成整條45公里的港島徑,其餘參加者則按自己的時間和體力,可選擇完成部份路段,時間約2至7個小時。屆時大家可以相約友好各自組隊出發,或者加入我們董事同工的行列,透過參與及支持明光大步走,顯示我們對香港社會上不同需要的關心,支持明光社繼續在性教育、傳媒教育、生命教育的恆常工作,將我們每年主持講座的數目由500多個繼續向上提升,讓更多中小學生可以有機會思考如何建立正確的價值觀、以及在一些重要的人生抉擇時有另一個可以參考的方向。

此外,今年內多個我們一直關注的議題都有新的挑戰,包括籃球賭博合法化、同志伴侶登記條例、因跨性別人士使用何種廁所而衍生的如何界定性別的問題等等。如何讓更多社會人士、教會同工和弟兄姊妹更了解當前的社會風氣及應如何回應是我們的負擔,希望大家能繼續支持我們。困難是一把兩刃劍,而我們期望在困難中更感受到大家與我們風雨同路,一起在荊棘叢中大步走。
